ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. AND WHEREAS, the recognition was granted by NRC to Ram Dev Degree College, G. T. Road, Jangiganj, Sant Ravidas Nagar, Bhadohi, Uttar Pradesh for B.Ed. Course vide order no. F. No./NRC/NCTE/F-3/UP-538/2002/9166-9173 dated 17.12.2002 Corrigendum F.NRC/NCTE/F-3/UP-538/2002/9384-9391 dated 20.12.2002 with an annual intake of 100 seats from the academic session 2002-2003.
- 3. AND WHEREAS, the institution Ram Dev Degree College, G. T. Road, Jangiganj, Sant Ravidas Nagar, Bhadohi, Uttar Pradesh has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed., which require additional facilities.
- 4. **AND WHEREAS,** it has been decided to permit the institution to have two basic units of 50 students subject to the institution fulfilling following conditions namely.
- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- (ii) The application-Institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2015. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The institution should have already identified/selected the faculty/staff by 29th February, 2016 for which the approval from the affiliating body for the same be submitted to this office immediately.
- (iv) The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.
- 5. Now therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to Ram Dev Degree College, G. T. Road, Jangiganj, Sant Ravidas Nagar, Bhadohi, Uttar Pradesh for conducting B.Ed. programme of two years duration with an annual intake of 100 for two basic units of 50 students from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein.
- 6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.
 - (a) Sanctioned programmes along with annual intake in the institution.
 - (b) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - (c) Name of faculty members who left of joined during the last quarter.
 - Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
 - (e) Fee charged from students.
 - (f) Available infrastructural facilities.
 - (g) Facilities added during the last quarter.
 - (h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
 - (i) The affidavit with enclosure submitted along with application.
 - (j) The institution shall be free to post additional relevant information, if is so desires.
 - (k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.

- 2. One scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:-
 - (i) The institution has acquired the land for setting up the teacher education institution.
 - (ii) The institution has constructed the building for conducting the course on the above mentioned land.
 - (iii) The institution has created an Endowment Fund of Rs. 5,00,000.00 (Rupees Five Lacs Only) and a Reserve Fund of Rs. 3,00,000.00 (Rupees Three lacs Only).
 - (iv) The institution has initiated the process for recruitment of Principal / Head of Department and teachers for the said course.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to 1993 Ram Dev Degree College, G.T.Road, Jangiganj, Sant Ravidas Nagar, Bhadohi, Uttar Pradesh 221301 for B.Ed. one year course from the academic session 2002-2003 with an annual intake of 100 (One Hundred) students Subject to fulfillment of the following:

- (a) That the institution will ensure that Principal / Head and at least Seven faculty members are in position for an intake of 100 (One Hundred) students before commencement of the course and a report of this effect duly verified by the Registrar of the concerned University shall be sent to the Committee within one month of commencement of the course.
- (b) The institution shall within ONE MONTH of the receipt of recognition order, convert the Endowment Fund account into a joint account in the form of FDR only for a period of not less than SIXTY MONTHS

 (Five years) in a Nationalized Bank. (and not any other certificate) to be operated along with an official of the Regional Committee.
- (c) That the Reserve Fund for an amount equal to three months salary of the staff be maintained, in the form of FDR in favour of the management / institution, for a period of not less than <u>SIXTY MONTHS</u> (Five years) in a Nationalized Bank.
- (d) The institution shall comply with the various all other norms and standards as prescribed in the NCTE Regulations.
- 4. Recognition is subject to the condition that the affiliating university shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE/UGC/Affiliating University.
- 5. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc.
- 6. The institution shall submit to the Regional Committee a <u>Self-Appraisal Report</u> at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.

- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
